About Peter Jackson:

Peter A. Jackson majored in critical philosophy for his BA at the University of Sydney. His MA dissertation in the philosophy department of Macquarie University (Sydney) explored issues in linguistic and epistemological relativism. He completed his PhD on the thought of the Thai philosopher monk Buddhadasa Bhikkhu at the Australian National University in 1986, and he is currently Professor of Thai history and cultural studies in the ANU's College of Asia and the Pacific. He has written extensively on modern Thai cultural history, with special interests in religion and sexuality. Peter Jackson was editor-in-chief of the Asian Studies Review, flagship journal of the Asian Studies Association of Australia, from 2009 to 2012 and he founded the Thai Rainbow Archives Project, which has collected and digitised Thai gay, lesbian, and transgender magazines and community organisation newsletters (see http://thairainbowarchive.anu.edu.au/index.html).

His most recent books are "The Ambiguous Allure of the West: Traces of the Colonial in Thailand" (Hong Kong University Press 2010, with Rachel Harrison), "Queer Bangkok: Twenty-First-Century Markets, Media and Rights" (Hong Kong University Press 2011) and "Thai Sex Talk: The Language of Sex and Sexuality in Thailand" (Silkworm Books, Chiang Mai 2012, with Pimpawun Boonmongkon). He is currently collaborating with Assoc. Prof. Thanes Wongyannava (Thammasat University, Bangkok) on the Australian Research Council funded project "Critical Thought in Thailand after Marxism", and with Dr. Narupon Duangwises (Princess Sirindhorn Anthropology Centre, Bangkok) on an edited collection on "Cultural Pluralism and Gender/Sex Diversity in Thailand".
